Shorten to only feature the introduction, one-pagers, and action plan


Move background chapter and situational assessment to appendix



Economic Impact Modeling

- > Requires estimated project spending on labor, materials, services.
- Assesses a project's likely impacts on the region, including indirect and induced impacts on jobs, income, and business sales/output.
- Results help residents, policymakers, and funders/investors understand the estimated economic potential of a proposed project.



Economic Impact Modeling

- 3 projects analyzed in fall 2021:
 - Phase 2 of Interior Gas Utility's natural gas buildout (<u>here</u>)
 - Water main line extension to Pearl Creek Elementary (<u>here</u>)
 - Polaris Building demolition (<u>here</u>)




What criteria should we use to select additional projects?

Proposed Criteria

- ☐ Is there sufficient information about the project to input into the model, such as project costs?
- Does the project represent a one-time capital investment?
- Does the project have high regional impact, demand, and support?
- Does the project create new jobs and/or grow regional wealth?
- Will the project address a time sensitive need?
- ☐ Does the project have likely funding and partners for implementation, including public and private sector?
- ☐ Is the project innovative and spark regional innovation?
- ☐ Does the project take advantage of existing strengths/opportunities?

Example Project Ideas

- Cold storage & food processing facility
- Titan natural gas plant expansion & rail spur extension
- KC-125 Basing at Eielson AFB
- North Pole health clinic
- Convention & arts center
- Pioneer Park Master Plan Phase
 2 (opening to riverfront & adding multi-purpose center)



What other projects should we consider?
